



## Terms and Conditions - Brisbane City Council – Brisbane Severe Weather Alert Competition

1. These terms and conditions set out all of the information regarding the Brisbane City Council – **Brisbane Severe Weather Alert** competition (the **Terms and Conditions**).
2. The promoter of this competition is Brisbane City Council ABN 72 002 765 795 acting through its Corporate Communication branch whose principal offices are at Brisbane Square, 266 George Street, Brisbane (the **Promoter**).
3. Information on how to enter this competition forms part of these Terms and Conditions.
4. Competition entry is deemed acceptance of these Terms and Conditions.
5. **Prize:** There are 13 prizes available as follows:
  - a) First prize: one (1) family holiday (two adults and up to three children under 14 years) for three nights stay at Tangalooma Island Resort on Moreton Island, including accommodation, ferry transfers and complimentary dolphin feeding, resort credits and day tours – valued at \$5000. Prize to be used by 1 December 2023
  - b) Second prize: one (1) 7x4 single axle heavy duty cage trailer – valued at \$3000

The Prize is not exchangeable or transferable, unless deemed so by the Prize provider, and cannot be redeemed for cash. If the full amount of the Prize is not redeemed, the unused balance will be forfeited. 6. **The competition period:** This competition will open at 12pm AEST on Wednesday 31 August 2022 and close at 11:59pm AEST on Thursday 1 December 2022. No entries will be accepted after this time.

7. **How to enter:** To enter the competition, entrants must either:

- (a) [register online](#) for free; or
- (b) [download the Weatherzone app](#) for free to your mobile device to receive push notifications. You will need to have registered a Brisbane Severe Weather Alert subscription to use this service.

The service is operated by The Weather Company Pty Limited ACN 078 711 930 trading as Weatherzone.

Only one entry per subscriber will be accepted. Any subsequent entries from the same subscriber will be deemed invalid.

Entrants must be subscribed at the time the Prize is drawn to be eligible to win the Prize.

8. **Eligibility:** To be eligible to enter this competition, a person must:
- a) successfully subscribe to the Brisbane Severe Weather Alert
  - b) be a resident of the City of Brisbane, and be able to provide evidence of this if required, and
  - c) not be an employee or contracted staff of the Promoter, and
  - d) be over the age of eighteen (18).
9. **Competition draw:** The winners will be the first 13 entries randomly drawn on Friday 2 December 2022 at 12pm AEST by an officer of the Promoter. The decision of that officer shall be conclusive and no correspondence will be entered into.
10. **Winner notification:** Winners will be notified by direct SMS message, phone call or email to the details used to subscribe to the Brisbane Severe Weather Alert system by an officer of the Promoter by 3pm AEST on Friday 2 December 2022.
11. **Prize Claim and Re-Draw:** To claim the Prize, the winners must respond to the direct message received from the Promoter providing the requested details, including their name and email address. If a winner does not claim the Prize or cannot be contacted by 12pm AEST on Monday 5 December 2022, an officer of the Promoter will redraw that Prize until a contactable winner has been located and that Prize is claimed.

Once the Prize is claimed, the Prize will be emailed to the email address provided by the Prize winner in the direct message to the Promoter.

12. **No liability of Promoter:** The Promoter accepts no responsibility whatsoever for late, misplaced, lost or ineligible entries. The Promoter makes no representations or warranties as to the quality, suitability or merchantability of the Prizes. To the extent permitted by law, the Promoter is not liable for any loss or damage whatsoever which is suffered (including but not limited to direct or consequential loss which includes but is not limited to loss of actual or anticipated profit, loss of goodwill, loss of reputation, loss of opportunity, loss of savings and/or loss of contract) or for any personal injury sustained in connection with the entry into this competition or acceptance of the Prize. This condition is not intended to exclude any liability which cannot be excluded under Australian consumer protection laws. Any such liability is limited to the resupply of the Prize.
